### **General Board Meeting Minutes**

August 6, 2019

The University Park Improvement District Board meeting was called to order at 7:05 P.M. Officers present were, President Don Turner, Treasurer Jenna Grater and Secretary Richard Seaton.

The minutes of the July meeting were discussed and approved.

#### **Old Business:**

The Treatment Facility Footing: This project is on hold until Don can find someone to do it at a reasonable price.

Richard to talk to Leon Hobson about the Footing project and screen at the facility and to tell Leon it's OK to use Economy Electric to do the electrical panel. Further, Richard to tell Leon that UP Board would like input on items UP pays for.

The lake and boat ramp committee is on hold until the lake goes down.

Issue of businesses run from homes in UP tabled until covenants revised.

Golf Course Committee. Has no volunteers. The Board decides to table the issue until spring. There is discussion about simply shutting down the golf course. This is also tabled.

Welcome sign: Application has been turned in. No response yet from County. Curt has purchased some of the materials.

No trash can project report.

Issue of home businesses tabled.

The plumbing repairs at the rental house have been completed.

Clubhouse rental fees and deposit: **People we just need to clean up after ourselves.** Kind of like ethical campers. Leave the space cleaner than you found it. There is discussion about a deposit of \$200. Jenna has a checklist for another project she believes she can adapt to the clubhouse. Tabled to September meeting.
